LOCATION

Horley is an affluent and well positioned town in Surrey within the borough of Reigate and Banstead. Crawley is approximately 6 miles south west and Reigate, approximately 6 miles north. The town benefits from its close proximity to Gatwick Airport, which is just two miles away, together with excellent road links to the M23 and in turn the M25. Commuters can easily reach London by train in around 30 minutes via the regular Thameslink service.
