LOCATION

The county town of Maidstone is located approximately 38 miles south east of London and 20 miles north west of Ashford. The town has a large catchment population of approximately 332,000 with an over representation of those within the highest AB and C1 social categories, and an extremely low rate of unemployment.

The town is served by excellent regional bus services and train links to central London, whilst also benefiting from good road communications with the M20 and M25, linking Maidstone to the surrounding towns and Dartford Crossing.

The property occupies a prime trading position on the southern end of the pedestrianised Week Street, adjoining **Card Factory** and opposite **EE**. Other nearby occupiers of note include **Clarks**, **WHSmith**, **Côte Brasserie**, **Trespass**, **Specsavers**, **The Works**, **Mountain Warehouse** and **M&S**. The property is a short walking distance from the town's two destination shopping centres, The Mall and Fremlin Walk.

Fremlin Walk benefits from 788 car parking spaces and is anchored by House of Fraser. Other notable tenants include JD Sports, Paperchase, Superdry, H&M, Fat Face, River Island, Boots, Zara, Pret A Manger, Waterstones and Bill's.
